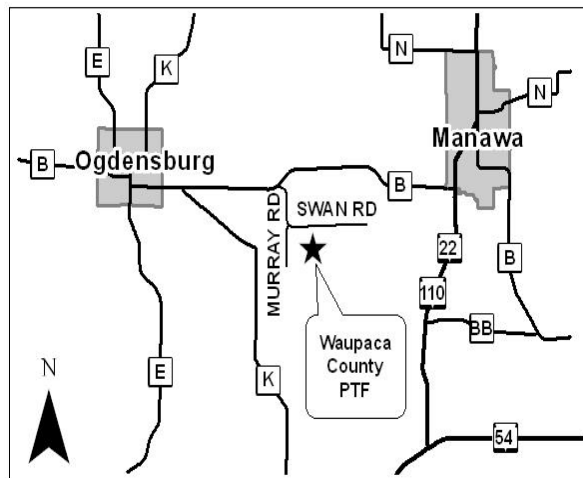

Flammable Solids (flares)
Peroxides (hardeners for fiberglass)
